

The General Shareholders' Meeting of Iberdrola was held on 17 June 2022 with the attendance of a total of 4,643,719,859 shares (1,427,894,893 in person and 3,215,824,966 by proxy), reaching a quorum of 72,13 % of the share capital (22,18 % in person and 49,95 % by proxy),

All of the resolutions proposed by the Board of Directors were approved. The votes for and against, blank votes and abstentions recorded for each of the proposals are indicated below:
