



The General Shareholders' Meeting of Iberdrola was held on 18 June 2021 with the attendance of a total of 4,224,969,018 shares (414,298,800 in person and 3,810,670,218 by proxy), reaching a quorum of 65.83 % of the share capital (6.46 % in person and 59.37 % by proxy).

All of the [resolutions](#) proposed by the Board of Directors were approved. The votes for and against, blank votes and abstentions recorded for each of the proposals are indicated below:
