Along 2024, Wind Europe engaged in some policy issues such as the EU legislative proposal on Electricity Market Design, the acceleration of permitting for wind (with the implementation of Overriding public Interest and digitalization), the Net-Zero Industry Act, Carbon Border Adjustment Mechanism, #100daysToElectrify campaign of the electrification alliance, engaging the new European Commission and the new Clean Industrial Deal with the focus on Industrial electrification/decarbonization and Strengthening the EU wind value chain, among other topics.

Wind Europe organizes conferences, exhibitions, seminars and workshops to encourage the exchange of information and ideas among wind energy stakeholders. The organization also hosts several annual events, including the WindEurope Technology Workshop, RE-Source, and the WindEurope Annual Event in Bilbao in 2024.
