Re: Implementation of the first paid-up capital increase approved by the General Shareholders' Meeting of Iberdrola, S.A. of 28 March 2014

Dear Sirs,

Pursuant to article 82 of Law 24/1988, of 28 July, on the Securities Market (Ley 24/1988, de 28 de julio, del Mercado de Valores) and related provisions, and as a follow-up to the notices of significant event (hecho relevante) filed with this National Commission on 29 April and 1 July 2014 (registry numbers 204,362 and 207,956, respectively), regarding the implementation of the paid-up capital increase approved by the General Shareholders' Meeting of Iberdrola, S.A. ("**Iberdrola**" or the "Company") of 28 March 2014, under section A of item six on the agenda (the "Capital Increase"), and pursuant to which the "Iberdrola Dividendo Flexible" (Scrip Dividend) system has been implemented, we hereby inform you that:

- The period for trading the free-of-charge allocation rights corresponding to the Capital Increase ended on 17 July 2014.
- During the period established for such purpose, the holders of 3,012,527,967 free-of-charge allocation rights entitled to accept the irrevocable commitment to purchase the referred rights assumed by Iberdrola (the "**Purchase Commitment**") have done so.
 - Therefore, Iberdrola has acquired such rights in the total gross amount of 343,428,188.24 euros.
- Iberdrola has waived the free-of-charge allocation rights acquired pursuant to the above and, therefore, the new shares corresponding to such rights.

- [Likewise, given that the maximum number of Iberdrola shares to be issued —after deducting the shares corresponding to the free-of-charge allocation rights acquired by Iberdrola pursuant to the Purchase Commitment (which Iberdrola has waived in accordance with the provisions of the preceding paragraph)— was a fraction, Iberdrola has waived 33 free-of-charge allocation rights that it holds in order for the number of new shares ultimately issued in the Capital Increase to be a whole number and not a fraction.]
- Therefore, the definitive number of ordinary shares with a unitary par value of 0.75 euros that will be issued in the Capital Increase is 67,239,000, with the nominal amount of the Capital Increase being 50,429,250 euros, which entails an increase of 1.078 % over the share capital of Iberdrola prior to the implementation of the Capital Increase.
- It is expected that, subject to compliance with all legal requirements (particularly that of the verification of such compliance by the National Securities Market Commission), the new shares will be admitted to trading on the Bilbao, Madrid, Barcelona and Valencia Stock Exchanges, through the Automated Quotation System (Electronic Market), on Thursday, 24 July 2014. In this respect, the ordinary trading of the new shares is expected to commence on Friday, 25 July 2014.

Please be advised of all of the foregoing for such purposes as may be appropriate.
