Subject: Implementation of the share capital reduction by means of the redemption of own shares approved by the General Shareholders' Meeting of Iberdrola on 29 March 2019

Dear Sirs,

Pursuant to article 227 of the restated text of the Securities Market Law approved by Royal Legislative Decree 4/2015, of 23 October (*texto refundido de la Ley del Mercado de Valores aprobado por el Real Decreto Legislativo 4/2015, de 23 de octubre*) and related provisions, and further to our notice of significant event (*comunicación de hecho relevante*) dated 17 June 2019 (official registry number 279,208), we hereby inform you that the Board of Directors of Iberdrola, S.A. ("**Iberdrola**" or the "**Company**") has resolved, at its meeting held today, to carry out the implementation of the share capital reduction by means of the redemption of treasury shares, approved by the General Shareholders' Meeting of the Company held on 29 March 2019 under item number ten of the agenda.

The share capital of Iberdrola has been reduced in the amount of 210,342,750 euros, through the redemption of 280,457,000 own shares. The share capital resulting from the reduction has been set at 4,680,000,000 euros, corresponding to 6,240,000,000 shares.

The aim of the share capital reduction is the redemption of own shares to further strengthen the *Shareholders' Remuneration Policy* of the Company and, therefore, it has not entailed a return of contributions, since the Company itself was the holder of the redeemed shares.

The share capital reduction has been carried out with a charge to unrestricted reserves by funding the redeemed share capital reserve in an amount equal to the nominal value of the shares redeemed. Such reserve may only be used by complying with the same requirements as those applicable to a reduction in share capital, as provided by section 335 c) of the Spanish Companies Act (Ley de Sociedades de Capital), which restated text was approved by the Royal Legislative Decree 1/2010, of July 2 (Real Decreto Legislativo 1/2010, de 2 de julio, por el que se aprueba el texto refundido de la Ley de Sociedades de Capital). Consequently, in accordance with the provisions of such section, creditors of the Company will not be entitled to assert the right of objection contemplated by section 334 of such act in connection with the approved reduction of share capital.

The required announcements of reduction of share capital will be published in the corporate web page of Iberdrola (<u>www.iberdrola.com</u>) and in the Official Gazette of the Commercial Registry (*Boletín Oficial del Registro Mercantil*) tomorrow, 19 June 2019.

Thereafter, the public deed regarding the reduction of share capital and the amendment of the Bylaws will be granted and registered with the Commercial Registry of Bizkaia and the Company will request the exclusion of the 280,457,000 shares redeemed from the Stock Exchanges of Bilbao, Madrid, Barcelona and Valencia through
