Determination of the reference price of the shares of “Iberdrola, S.A.” and of the resulting strike price in connection with the issuance by “Iberdrola Finanzas, S.A.” (Sociedad Unipersonal) of equity-linked green bonds linked to the shares of “Iberdrola, S.A.”, for an amount of EUR 400 million and due 2030

Pursuant to article 227 of Act 6/2023, of March 17, of the Securities Markets and Investment Services (*Ley 6/2023, de 17 de marzo, de los Mercados de Valores y de los Servicios de Inversión*), and related provisions, and further to our notices of other relevant information (*comunicaciones de otra información relevante*) filed with this National Commission on 20 March 2025 (with official registry numbers 33,568 and 33,582), we hereby inform you that the reference price of the shares of “Iberdrola, S.A.” (the “**Company**”) in connection with the issuance by “Iberdrola Finanzas, S.A.” (Sociedad Unipersonal)¹ (the “**Issuer**”) of equity-linked green bonds referenced to the value of the shares of the Company for an amount of EUR 400 million and due 2030 (the “**Bonds**”), was determined yesterday, 3 April 2025.

The strike price for the purposes of the option embedded in the Bonds will be EUR 17.7406 per share, which represents a 20% premium over the reference price of the Company’s shares, calculated as the arithmetical mean of the volume-weighted average prices of the shares of the Company on the Spanish Stock Exchanges over the trading sessions comprised between 21 March and 3 April 2025 (inclusive), which was EUR 14.7838.

Such strike price matches that of the call option purchased by “Iberdrola Financiación, S.A.” (Sociedad Unipersonal)² over shares of the Company to hedge the exposure of the Issuer to any cash amounts payable in connection with the exercise of the option by the holders of the Bonds.
