Changes in the composition and positions of the Board of Directors and its committees

Pursuant to article 227 of *Act 6/2023, of March 17, of the Securities Markets and Investment Services (Ley 6/2023, de 17 de marzo, de los Mercados de Valores y de los Servicios de Inversión)*, and related provisions, we hereby inform you that the Board of Directors of “Iberdrola, S.A.” (the “**Company**”), at its meeting held today, has passed, among others, the following resolutions:

- (a) To appoint Mr Pedro Azagra Blázquez as director of the Company, with executive status, by the co-opting procedure and for the period remaining until the holding of the General Shareholders’ Meeting, and also as chief executive officer, in both cases with the prior favorable report of the Appointments Committee, to cover the vacancy generated by the resignation offer presented by Mr Armando Martínez Martínez from the aforementioned two posts.

Mr Azagra Blázquez held to date the position of “Avangrid, Inc.” chief executive officer, subsidiary of Iberdrola Group in the United States of America.

- (b) To place on record, in accordance with article 30.4 of the *Regulations of the Board of Directors*, that Mr Pedro Azagra Blázquez will be a member of the Company’s Executive Committee since he has been appointed chief executive officer and, for the appropriate purposes, to appoint him as member of the above-mentioned committee.
- (c) To set, following the proposal of the Appointments Committee, the number of members of the Company’s Executive Committee at six.
- (d) To appoint, following the proposal of the Appointments Committee, Ms Nicola Mary Brewer as new chairperson of the Company’s Sustainable Development Committee, replacing Ms Sara de la Rica Goiricelaya, who shall remain as a member of the referred committee.
