On the same theme, Iberdrola has designed a corporate social responsibility plan entitled "Responsible energy for people", which sets out seven priorities, 50 working lines and more than 300 actions aligned with the United Nations Sustainable Development Goals (SGD). The company's most significant contributions to achieving the sustainable development goals focus on two main areas: affordable, non-polluting energy supplies (goal 7) and action for the climate (goal 13), although the company also contributes to the remaining goals.

According to the general manager of Forética, Germán Granda, "Forética and Iberdrola will work together to implement innovative solutions in the company's everyday management in line with leading international trends regarding society, the environment and accountability. It is also a place to get together and share useful knowledge and experience from the stakeholders' network.

This year, Iberdrola has received some important recognition for its work in the CSR area, which includes the World Finance Corporate Governance Award to the best company in Spain and being the only Spanish company to appear on the list of the 128 most ethical companies in the world, according to the World's Most Ethical Companies by Ethisphere Institute. What's more, the company is the only European electricity company selected in 19 editions of the Dow Jones Sustainability Index and the only Spanish electricity company included, for the second consecutive year, in the Bloomberg Gender-Equality Index 2019.
