<u>Subject:</u> <u>Other relevant information / periodic information and termination of the share</u> buy-back programme of Iberdrola, S.A.

Reference is made to our notice of other relevant information of 11 May 2021 (official registry number 9,361, the "**Initial Notice**"), relating to the buy-back programme of own shares approved by the Board of Directors of Iberdrola, S.A. ("**Iberdrola**" or the "**Company**") in accordance with the authorisation granted by the General Shareholders' Meeting held on 13 April 2018 under item twelve of its agenda (the "**Buy-back Programme**").

Pursuant to article 227 of the restated text of the Securities Market Law approved by the Royal Legislative Decree 4/2015, of 23 October (texto refundido de la Ley del Mercado de Valores aprobado por el Real Decreto Legislativo 4/2015, de 23 de octubre) and related provisions, and in accordance with articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 supplementing Regulation (EU) No 596/2014 of the European Parliament and of the Council with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures (the "Regulation 2016/1052"), we hereby inform you of the following:

- The Company will not acquire any more shares under the Buy-back Programme. Consequently, from 12 May 2021 and until the end of today's trading session, Iberdrola will have acquired 14,799,092 own shares under the Buy-back Programme, representing 0.23 % of the share capital of the Company.

It is hereby stated that the acquisition of own shares under the Buy-back Programme has been communicated on a regular basis, in accordance with the provisions of articles 2.2 and 2.3 of *Regulation 2016/1052*, and has been carried out pursuant to the terms and conditions established in such regulation.

Finally, we hereby inform you that the own shares acquired under the Buy-back Programme will be redeemed in the context of the reduction in share capital submitted for approval by the General Shareholders' Meeting to be held on 17 or 18 June 2021, on first and second call, respectively under item six of the agenda. If approved, such share capital reduction must take place within one month from the date of conclusion of the Buy-back Programme (that is, before 10 July 2021).
