

## 2019 General Shareholders' Meeting – Quorum and Voting Results

The General Shareholders' Meeting of Iberdrola was held on 29 March 2019 with the attendance of a total of 4,832,991,044 shares (829,606,938 in person and 4,003,384,106 by proxy), reaching a quorum of 74.12% of the share capital (12.72% in person and 61.40% by proxy).

All of the [proposed resolutions \[PDF\]](#) submitted by the Board of Directors were approved. The votes for and against, blank votes and abstentions recorded for each of the proposals are indicated below:
